Terms and conditions – Free Stock Promotion Terms and Conditions

1. Capital Markets Elite Group (UK) Limited (“**the Firm**”, “**we**”, “**our**”, “**us**”, “**CapitalMEG**”) is authorized and regulated by the UK Financial Conduct Authority to carry on the business of a Broker-Dealer.
2. Participation in the Free Stock promotion is bound by these terms and conditions (“**Promotion Terms**”) and is therefore considered an annexure to the terms and conditions contained within your client agreement, including any supplemental agreements and disclosures that apply to your account.
3. The Firm will not be responsible in any manner for any damages, losses, or expenses, however caused by the alteration, amendment, or termination of this promotion. We may make changes to these Promotion Terms by posting the modified terms on our website. We recommend you revisit these Promotion Terms regularly, and by your continued use of our services, you accept any such modified terms. If any term of these Promotion Terms is found to be illegal, invalid, or unenforceable under any applicable law, such term shall be deemed omitted from these Promotion Terms and shall in no way affect the legality, validity, or enforceability of the remaining terms.
